Merit:

All applications are judged on their own merit and will be appointed by the Junior management committee. Our objective is to appoint quality coaches that are suitably matched to a team. Consideration will be given to the applicant's knowledge, experience and personality in relation to the age group they are applying for. For example, a person who has coached successfully at senior level may have the appropriate football knowledge and experience but may not have the personality and patience required to coach a younger age group. It is understood that in junior teams the successful applicant will coach whichever team their child or sibling is graded into. An applicant does not have to have a child of their own either playing at the club or in the team they are applying to coach for. In this case the appointed Coach will be required to obtain or produce a current "Working with Children" card.

Tenure:

Coaches are appointed for a one (1) season tenure. Commencing from date of appointment and terminating on the completion of the Season's Presentation Day. All Coaches positions are then deemed to be vacant and applications will be sought from both existing coaches and new people for the following season.

Dismissal:

The Club reserves the right to dismiss a coach without prior notice if the Executive Committee feels justified in doing so.
